University Lecture - Education and Healthcare: The Equitable Imperative for Jamaica

(AFJ)/Cobb Family Foundation (CFF) Lecture Series will examine policies and actions that impact hidden biases and disparities in education and healthcare. The lecture to be presented by Her Excellency, The Honorable Aloun Assamba, JP, is entitled, "Education and Healthcare: The Equitable Imperative for Jamaica."

Ambassador Sue Cobb, Former United States Ambassador to Jamaica and President of CFF comments, "The need for access to quality education, safe, effective and affordable healthcare is an opportunity for innovative minds to find practicable solutions. Her Excellency, The Honorable Aloun Ndombet Assamba is a lawyer, politician and diplomat. She was formerly Member of Parliament for St. Ann South Eastern and served as Jamaica's Minister of Tourism, Entertainment and Culture. She served as High Commissioner for Jamaica in London from 2012 to 2016. Ambassador Assamba is currently Chief Executive Officer, COK Sodality Credit Union.

The purpose of the Lecture Series is to showcase leading experts who illustrate and stimulate debate across a range of thought-provoking issues.
